**AUTOPSY REPORT**

**Summary:**

A largely complete body apart from right rib, left patella and phlanges of the right foot which were missing. There was still a little clothing with a pocket knife and a wallet in a plastic bag in the body bag.

As established from anthropology examination, this person was a man aged between 24 and 40 and measuring approximately 182.5cm +/- 7.7cm in height. There were no particular identifying features.

He died from probable gunshot injuries to the chest where there was damage to the ribs on the left side of the chest directed inwards and damage to ribs on the right side.

There were possible additional gunshot injuries to the left humerus, right ulna, to left femur causing fragmentation of lower third and comminuted diagonal fracture of mid third of left fibula.

**Gunshot injury to chest**

H. SUMMARY AND CONCLUSIONS

A LARGELY COMPLETE BODY APART FROM RIGHT RIB 1, LEFT PATELLA AND PHALANXES OF RIGHT FOOT WHICH WERE MISSING. THERE WAS SIN A LITTLE CLOTHING WITH A POCKET KNIFE AND VALLET IN PLASTIC BAG IN BODY BAG.

AS ESTABLISHED FROM ANTHROPOLOGY EXAMINATION THIS PERSON WAS A MAN AGED BETWEEN 29 AND 40 AND MEASURING APPROXIMATELY 182.5 cm  $\pm$  7.7 cm IN HEIGHT

HE DIED FROM PROBABLE GUNSHOT INJURIES TO THE CHEST WHERE THERE WAS DAMAGE TO RIBS ON LEFT SIDE OF THE CHEST DIRECTED INWARD AND DAMAGE TO RIBS ON RIGHT SIDE.

THERE WERE POSSIBLE ADDITIONAL GUNSHOT INJURIES TO LEFT HUMERUS, RIGHT ULNA, TO LEFT FEMUR CAUSING FRAGMENTATION OF LOWER THIRD, AND COMMINUTED DIAGONAL FRACTURE OF MID THIRD OF LEFT FIBULA (continue on back of page as required)
