Reports that after capture on July 14, 1995, he and other POWs were driven through Zvornik and were subjected to stoning by Serbian women and children [important to show the level and breadth of popular resentment against Srebrenica Moslems]

[2] “Many dead bodies” in the village of Lipanj “after you pass the schoolhouse.... Actually there were bodies all over the area, and we came across bodies every ten to fifteen minutes.”

Additional remarks of interest: Witness was captured in Memici and transported to Batkovic POW camp, where he was registered by the Red Cross. Eventually transferred to Kotorsko POW camp and exchanged on 24 December 1995. Was told by a Batkovic guard that about 3000 Moslem POWs were being held in Vlasenica and he expresses acceptance that this allegation may be true.
